**Intended use:** Used for external and internal walls, roofing of industrial, service, food, cold storage, residential and public buildings including healthcare facilities.

**The substantive basis for issuing the certificate:** Application (Institution submitting the product for assessment: Adamietz Sp. z o. o., ul. Braci Prankel 1, 47-100 Strzelce Opolskie) dated 23.05.2024 (No. 322/84/84/2024) together with the required documentation.

**According to the currently available knowledge, the assessed product (when used in accordance with the manufacturer's guidelines) should not pose a risk to human health.**

#### Recommendations and comments:

- The product must be used in accordance with the manufacturer's guidelines.
- The approval does not apply to the use of the product in direct contact with food.
- Proceed in accordance with the information contained in the Safety Data Sheet.
- Premises in which the above-mentioned products are used should be ventilated until the smell disappears.
- The label should be marked in accordance with current legislation.
- Handle construction waste in accordance with current legislation.
- The certificate does not concern the health and safety conditions during the installation of the product.
- When used in healthcare facilities, the requirements of the Decree of the Minister of Health of 26 March 2019 (Journal of Laws 2019, Item 595 of 29 March 2019) and the currently applicable legislation must be taken into account.

Hygienic certificate does not include the assessment of the utility values, technical parameters and allergenic properties of the product.

The certificate may be changed or cancelled after presenting relevant evidence by either party. This certificate expires after 5 years from the date of its issue or in the case of changes in the recipe or production technology of the product, its intended use and after changes of legal regulations related to the assessed product.

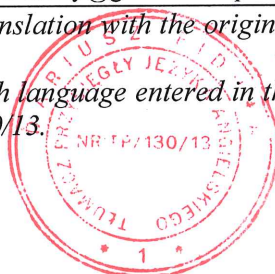
